Brandt moved to approve as presented and submit to Sawyer County for approval, seconded by Baumann. Discussion followed. In reviewing the amendments, it was decided that on page 7, 4.4N 3(b), they would remove SCLWD and 4.4R 3(c) eliminate the word Department (2 places). Ross asked the Chairman of the Plan and Review Commission to contact Sawyer County representative to clarify Section 30 on page 2.

The Committee discussed the Driveway Ordinance relating to Sawyer County Zoning Ordinance. It was decided that the Driveway Ordinance should be enforced as it is written.

Krause moved to approve with the changes made, seconded by Baumann and close discussion. All in favor, motion carried. Motion to adjourn to the recessed Town Board Meeting was made by Krause, seconded by Baumann.
